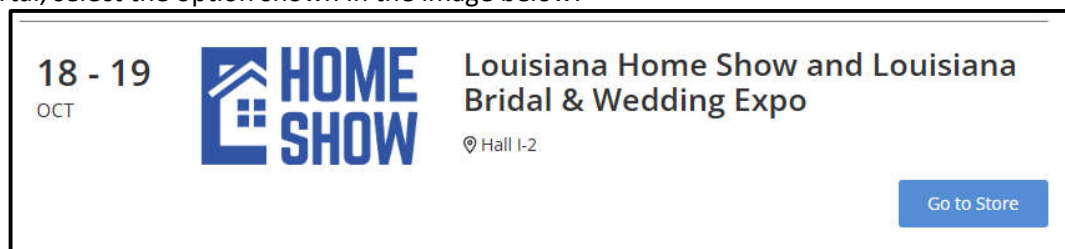

Important Utility Ordering Instructions
